**Purpose:** To report and comment upon 60 expressions of support and 25 objections to the experimental waiting restrictions for the aforementioned locations.

**Summary:**

The report summarises expressions of support, comments and objections to the experimental waiting restrictions and in consideration thereof recommends that the Order be implemented in full.

## Background

1. Following requests from Ward Members to promote experimental waiting restrictions on Threadfold Way, Cottonfields, Scholars Rise, School Street, Eagley and Birtenshaw Crescent & Bromley Cross Road, Bromley Cross, Bolton, an experimental order was approved by the Director under the Scheme of Delegation. The order was advertised and placed on the above named road in October 2013 with an intention to review in April 2014.. Some expressions of objections and support were received during this period and in April 2014 a further consultation was undertaken. Responses from this consultation were collated with expressions previously received and as a result:-

## **Objections**

### Threadfold Way, Cottonfields, Scholars Ride, School Street, Eagley

6. The majority of objectors do so on the grounds of loss of available parking within the area, this also being an issue for visitors and workmen in the area
7. Some objectors have expressed support for some restrictions but feel that in their current form they are excessive.
8. Some objectors have expressed concern that with the roads clear of stationary traffic, this has led to an increase in vehicle speed in the area.
9. There has been concern expressed by some objectors that the yellow lines showing the restrictions have aesthetically ruined the outlook of the area and that this together with lack of parking will lead to a decrease in valuation of their properties.
10. One objector has expressed concern for their personal safety in having to walk further to their property.
11. An objector has questioned how the scheme is being funded.

## **Support**

### Threadfold Way, Cottonfields, Scholars Ride, School Street, Eagley

12. A large number of those expressing support have commented that they would like to see the experimental restrictions be made permanent in their entirety.
13. A small number of those in support of the restrictions have requested we consider reducing the lines in some areas to assist in parking for residents, visitors & workmen.
14. A small number of those expressing support for the restrictions have requested that we consider increasing the areas covered by waiting restrictions to deal with displacement issues following the introduction of the restrictions.
15. A number of those expressing support have stated that introducing the restrictions has resulted in it being a safer environment to walk through.

16. One supporter has requested we consider the introduction of speed humps to reduce vehicle speed which has resulted now the area is clear of traffic
17. One supporter has expressed that the road is now safer without vehicles racing for gaps in parked vehicles to pass oncoming traffic.

## Observations

18. The Executive Member is reminded that the Experimental Restrictions are as follows:-

### Deletions:-

#### No Waiting At Any Time

Threadfold Way, both sides- from its junction with Eagley Brow to its junction with the new un-named car park access road.

### Additions:-

#### Experimental No Waiting at Any Time.

Threadfold Way, southwest side	-	from its junction with Hough Lane for a distance of 188 metres in a north westerly direction.
Threadfold Way, northwest side	-	from its junction with Hough Lane for a distance of 194 metres in a north westerly direction
Cottonfields, north side	-	from the projected westerly kerbline of Threadfold Way for a distance of 15 metres in a westerly direction.
Cottonfields, south side	-	from the projected westerly kerbline of Threadfold Way in a westerly direction for a distance of 167 metres to its cul de sac end
School Street, both sides	-	from a point 85 metres west of its junction with Hough Lane in a westerly direction around its Cul De Sac end.
Scholars Rise, west side	-	from the projected northerly kerbline of Threadfold Way for a distance of 92 metres in a northerly direction
Scholars Rise, east side	-	from the projected northerly kerbline of Threadfold Way for a distance of 29 metres in a northerly direction

19. There has been a larger proportion of supporters to the restrictions than objectors, however some of these along with objectors have expressed a wish for the length of restrictions to be reduced to assist delivery / workmen to park .It is however felt that relaxation of any of the current restrictions would in all likelihood lead to permanent resident parking. The Executive Member is reminded that dispensation for workmen parking can be obtained in advance from Parking Services. Parking purely for the purpose of loading / unloading is still permitted.

20. The Executive Member is reminded that the experimental restrictions were introduced at the request of Ward Members to address indiscriminate parking issues in the area causing obstruction/access issues to residents and in this respect they would appear to be a success.
21. The Executive Member is reminded that under the conditions of Experimental Restrictions, it is not possible to increase the length of restrictions only to approve or reject restrictions in an area. If they were to be relaxed in an area without some form of time restriction being imposed it is likely that this would result in long term resident parking taking place. There is no additional funding available to consider an extension of the restrictions this at this time.

### **Recommendation**

22. Taking into account views expressed during the consultation, it is now recommended that the experimental restrictions approved in their entirety. It is further recommended that the Borough Solicitor be authorised to make the revised order.

### **Views of Consultees**

23. Representatives of the Chief Constable, County Fire and Ambulance Officers have been consulted on the introduction of the Experimental Order and have not commented on the proposal.
24. Parking Services & The Licensing Unit have been consulted and have not commented on the proposal.
25. Ward Members have been consulted on this report and fully support the recommendation requesting that the experimental order be made permanent in its entirety.

### **Financial Implications**

26. The estimated cost of promoting this Traffic Regulation Order is £6,850, which includes promotion, consultation and works costs. This will be funded by the Bromley Cross Area Forum.

### **Implementation**

27. If the recommendation that the Experimental Order be confirmed and that the Traffic Regulation Order should be made as soon as the remaining legalities have been completed.
