7. APPLICATION FOR A LICENCE TO DRIVE PRIVATE HIRE VEHICLES AND MISCONDUCT BY A LICENSED PRIVATE HIRE OPERATOR LER/18/19

(Councillor P. Wild declared an interest in the following item as he knew the applicant and left the room taking no part in the discussions or vote thereon.)

Councillor Dean as the Vice-Chairman here took the Chair.

The Director of Place submitted a report which gave details of an application which had been received for a licence to drive private hire vehicles which had previously lapsed and also misconduct by a Licensed Private Hire Operator.

The report outlined the full details of the application and alleged misconduct.

The applicant and his solicitor attended the meeting and provided verbal evidence.

It was moved by Councillor Bagnall and Seconded by Councillor Haworth that the licence to drive a private hire vehicle be refused but no action be taken in relation to operate private hire vehicles.

Whereupon the motion was declared carried and it was specifically Resolved -

That the application to drive a private hire vehicle be refused on the basis that the Committee is not satisfied that the applicant is a fit and proper person to hold a licence.

The Sub-Committee also took account of –

- The conviction for using a vehicle uninsured against third party risks from December, 2018;
- The applicant was convicted of speeding on a public road in July, 2017;
- The pattern of previous offences in relation to exceeding the speed limit;
- Matters around the Council's Statement of Fitness and Suitability. A person with two or more intermediate traffic offences where the conviction dates are less than 3 years will be referred to Committee for consideration. Two or more convictions which are less than three years will generally mean that a person applying for a licence will normally have their application refused; and
- The Committee also considered two references and additional information which the Committee considered.

Members of the public and in particular, the elderly, infirm and children or vulnerable adults entrust their personal safety and wellbeing to private hire operators and drivers whenever they take a journey. Passengers often travel alone and are vulnerable to inappropriate behaviour.

The Committee's primary duty is of concern for the safety and well-being of the public.

There is therefore reasonable cause to refuse the private hire drivers licence. No action will be taken in relation to the Operators Licence.
