Refused.

The proposed residential development of the application site would represent inappropriate development of **'Other Protected** Open Land' and therefore would be contrary to Policy CG6AP of Bolton's **Allocations Plan** and Policies **OA1.4** and **OA1.6** of Bolton's Core Strategy. The proposed development would also not maintain or respect the character and appearance of the area, contrary to Policies CG3 and **OA1 of Bolton's** Core Strategy. Applying the "tilted balance" of paragraph 11 of the National **Planning Policy** Framework, it is considered that the adverse

impacts of the development would significantly and demonstrably outweigh the benefits of the proposed development.
