					Although 69,000 payments have already been made to residents who pay their Council Tax by direct debit, there are nearly 1 in 3 households in this borough who do not pay by direct debit and have not yet received their £150 entitlement. Unless this Council acts swiftly, we may find that the £150 payment due to some of the borough's least well off, will actually be paid out AFTER the first instalment of £325 payment in July of the latest government initiative which was announced 16 WEEKS after the original £150 payment was announced.
					Nationally, approximately 1.3 million adults do not have a bank account and if indicative of the national figure, this represents nearly 10,000 adults in this borough. It is widely accepted that it is the least well-off who do not have bank accounts – the very people who now desperately need help with their utility bills.
					The online application for non-direct-debit residents finally appeared on 28th May 2022 on the Council's website and both Cllr Newall and I have facilitated Kearsley residents in the application for their £150 payment. However, it is impractical and simply wrong to expect Councillors to ensure that the estimated 1,500 households – that fall into the non-direct-debit payers category - per ward are claiming their £150 entitlement.

					The FOI information subsequently makes clear that the reason for the cancellation of the build at Haslam Park was due to "challenges" with the scheme, and the DfE noting that this "questions the viability of the site".
					As this guidance from the DfE was already quite clear, the questions are simple:
