## 1. Background

Governing boards wishing to reconstitute or vary their instrument of government must do so under the School Governance (Constitution) Regulations 2012. The 2012 regulations allow for a minimum of 7 governors with no maximum number. The constitution must allow for the head teacher (if they choose to be a governor), only one elected staff governor, at least two elected parent governors and only one local authority governor (currently named 'authority governor').

The governing board may also appoint such number of co-opted governors as they consider necessary provided that the requirements in regulation are met in respect of governing boards of foundation and voluntary schools. Staff may be appointed as co-opted governors but when counted with the staff governor and head teacher category, must not exceed 1/3 of the total membership of the governing Board.

Voluntary aided schools must have sufficient foundation governors to outnumber the other categories of governors by two. Voluntary controlled schools must have at least two foundations governors as part of their constitution (no more than 25% of the total governing Board)

## 2. Amendment to Instruments of Government for Roman Catholic Schools (parish boundary changes)

The Diocese of Salford have requested the amendment of Instrument of Government to reflect the amalgamation of parishes to form new parishes with new parish names.

The Diocese have therefore requested that that Instruments of Government be amended to reflect the new parish names for the following schools:

Our Lady of Lourdes – Our Lady of Lourdes and St Gregory the Great  
 SS Osmund and Andrew's, Brightmet – Blessed Dominic Barberi  
 St Teresa's, Bolton – Blessed Dominic Barberi  
 SS Peter and Paul's – St Edmund and St Patrick  
 St Bernard's – Christ the Redeemer  
 St Ethelbert's – Christ the Redeemer  
 St William of York – Christ the Redeemer  
 St Joseph's, Halliwell – St Cuthbert's  
 St Thomas of Canterbury – St Cuthbert's  
 St Brendan's – Corpus Christi  
 St Columba's – Corpus Christi  
 St John the Evangelist – Corpus Christi
