The Sub-Committee also took account of -

- The driver's convictions on 31st July, 2019 for plying for hire without a hackney carriage proprietor's licence and using a vehicle uninsured against third party risks;
- Matters around the Council's Statement of Fitness and Suitability policy in relation to plying for hire in that a serious view is taken when a driver is convicted of offences under the Town Police Clauses Act, 1847 and the Local Government (Miscellaneous Provisions) Act, 1976;
- The offence of using a vehicle uninsured against third party risks is a major motoring offence under the Council's Statement of Fitness and Suitability; and
- At the meeting the driver indicated that he had pleased guilty to both offences at court.

Members of the public and in particular, the elderly, infirm and children or vulnerable adults entrust their personal safety and wellbeing to private hire drivers whenever they take a journey. Passengers often travel alone and are vulnerable to inappropriate behaviour.

The Committee's primary duty is of concern for the safety and well-being of the public.

There is therefore reasonable cause to revoke the private hire drivers licence.
