## 39. NOTICE OF MOTION UNDER STANDING ORDER NO. 4 - IDENTITY CARDS ACT 2006

It was moved by Councillor R. Silvester and seconded by Councillor Gradwell -

That this Council believes that the Identity Cards Act 2006 will be expensive, intrusive and ineffective and that it will have an impact upon all of the people of Bolton Metropolitan Borough.

That this Council also believes:-

- the proposed scheme may well impose costs on the Council itself in terms of ensuring compatibility of operations;
- (2) the cost to each individual will be over £90 to obtain one of the new combined ID Cards and passports;
- (3) the London School of Economics estimated the cost of the Identity Cards Scheme could be as high as £20 billion three times government estimates. The LSE put the lowest cost to each individual at £170, and is more likely to be £300;
- (4) the ID Card and Database will fundamentally alter the relationship between the state and the individual each individual will have a mandatory responsibility for updating their personal details with the state and failure to do so could lead to a fine; and
- (5) the money that the ID Cards Scheme and database will cost would be better spent on the strengthening of the Police, the Security Services and a National Border Police force.

That this Council resolves to:-

(A) take no part in any pilot scheme or feasibility work in relation to the intreductron of National Identity Cards;

- (B) ensure that National Identify Cards will not be required to access Council services or benefits unless specifically required to do so by an Act of Parliament; and
- (C) only co-operate with the National Identify Card scheme where to do so would otherwise be unlawful.

Upon being put to the vote, the motion was declared carried.

# 40. NOTICE OF MOTION UNDER STANDING ORDER NO. 4 - PAYMENT OF TELEVISION LICENCES AT POST OFFICERS

It was moved by Councillor R. Ronson and seconded by Councillor David Wilkinson -

That this Council condemns the actions of the Labour Government in taking away the opportunity for people to pay for their television licences at Post Offices in the Metropolitan Borough of Bolton

This Council believes that this is further evidence of the total lack of support for the Post Office network by successive Governments, leading to many Post Office closures in the Bolton Borough. This Council accordingly calls upon the Government to re-instate the ability for customers to pay for television licences at Post Offices.
