Apologies were received from Councillor Mrs Pat Barrow.

1. INTRODUCTION

Councillor Bob Ronson welcomed everyone to the meeting, led the introductions and then explained the format for the meeting.

2. HELPING OLDER PEOPLE TO STAY INDEPENDENT AND PREPARE FOR THE FUTURE

Councillor Bob Ronson explained there would be a presentation on Helping Older People to stay independent and prepare for the future which was given by Ellen Miller, Assistant Director of Strategy and Commissioning, Adult Services.

The basis of the presentation looked into what mattered to the people of the Two Towns Area Forum and it was established that there were four main basic concerns around care support, domiciliary care, long term care and specialist/targeted care. It also highlighted that a third of the Adult and Social care budget was spent on just 1% of the population.

Ms Miller emphasised that the basic requirement was to maintain care standards for people aged 65 plus with the aim of keeping them in their homes using residential and nursing care. However, with the current economic climate, Ms Miller said that there were going to be difficult times ahead financially.

She stressed that it was vital that community and voluntary groups were kept involved and included at all stages in order that local communities were able to still provide a service for the most vulnerable in the area.

After the presentation, there were round table group discussions after which the residents were invited to ask questions.

The discussions produced a few areas for concern such as where do people go to access support and it was felt that agencies and departments ought to advertise and communicate better in order to promote their services.

Q.1 Councillor McKeon asked about personalised budgets?

A.1 Ellen Miller responded that there was a high uptake of younger people and people with mental health issues applying for personalised budgets, but not many elderly people.

Q. 2 Councillor Robert Ronson asked how people with specific needs could buy a 'service' with a personalised budget?

A.2 Ms Miller said that this process had not been finalised and there could be a wait of six months before contracts were sorted as they had not got specialists in yet. Also it was stated that 50% of commissioned services would be bought in.

Ms Chadwick from the Horwich Befriending Service made a comment that there been cuts in their funding recently, and now they were going to be able to help and support much less people and they had a waiting list already. She said that with budget cuts it would mean that more and more elderly people would now have to rely on volunteers to help them fill in forms to claim for benefits which they were entitled to.

Resolved – That the report be noted.
