**Re: Local Government (Miscellaneous Provisions) Act 1982
Renewal of Licence: Private Shop – 201 St. Georges Road, Bolton, BL1**

Please find enclosed our application for the renewal of our licence under Schedule 3 of the above Act, in relation to the above premises. We will pay the fee of £637.00 by BACS.

You will note that this application for renewal is made in the joint names of Darker Enterprises and Private Shops UK Ltd. The reason for this is that we have been advised that we should restructure to put our retail operations alone into one company. Our difficulty is that we would have to do this on one date rather than move control on a staggered basis.

We have, therefore, been advised that the solution is to renew all our licences in joint names and to continue to operate them under Darker Enterprises until we can transfer them over as licenced premises. Both companies are subsidiaries of Roldvale Trading Ltd so there would be no change in staff, methods of operation or policy. We plan to put this into effect when we have virtually all our licences issued on this basis and intend to give notice to all the appropriate local authorities. There would be no noticeable change whatsoever except that the various notices in the premises would change on the date.

We trust that it is clear that this is purely an administrative, financial and organisational change. However, if you require any further clarification, we would be happy to arrange for our management consultant to talk to you.

With regard to item (ii) of the notes to applicants, there has been no change in planning permission since our last application.

We understand that certain Councils distribute copies of applications to members of the public and we have, therefore, enclosed the private address in a separate envelope marked "Private & Confidential" in order to protect the family home. We should be grateful if the Council would observe the confidentiality of this information and not release same to members of the public.

We confirm that we have sent a copy of this application to the Chief Superintendent Greater Manchester Police. We also confirm that the public notice will be published in a

local paper and a copy of the notice will be displayed at the premises for a period of 21 days from the date of application.

Will you please note that any Licence issued should be in the name of Darker Enterprises Limited, the applicant, and all communication relating to the above premises should be directed to this office.
