### **19. MINUTES OF PREVIOUS MEETING**

### **20. EXCLUSION OF PRESS AND PUBLIC**

### **21. APPLICATIONS FOR HOME TO SCHOOL TRANSPORT**

The Director of People submitted a report which put forward four applications which had been received for funding towards home to school transport.

It was noted that the application submitted on behalf of IHB and NHB had been deferred at the meeting on 26<sup>th</sup> January, 2020<sup>1</sup> for further information. (Minute 16 of that meeting refers). Additional information was now provided in this regard.

Resolved – (i) That the application submitted on behalf of IHB and NHB be refused in accordance with the Council's Policy.

(ii) That the application submitted on behalf of AHY be refused, in accordance with the Council's Policy.

(iii) That, in respect of the application submitted on behalf of AK, assistance be provided for a taxi to and from the required school, up to the end of the July 2023 School Term.

(iv) That, in respect of the application submitted on behalf of PM, a bus pass to the required school be provided for the remainder of their primary school education, and that options be explored regarding the provision of home to school transport by the LEA from September, 2021 as an alternative option.
