35. ITEM REFERRED TO COUNCIL FROM SCRUTINY COMMITTEE – LAND AT SINGLETON AVENUE

That the decision should be referred to Council with a recommendation that the Executive Cabinet Member Deputy Leader portfolio resolves not to sell the land but retain it as open green space for the continuing benefit of residents in Horwich

This Council believes that the decision made by the Executive Cabinet Member, Deputy Leader to dispose of Council owned land off Singleton Avenue, Horwich should be reversed. Council believes that this land is a valuable community asset of open green space and should be available for use for the continuing benefit of residents for recreation and leisure purposes as was the case before being included in the Allocations plan. Council believes that the Executive Cabinet Member, Deputy Leader should listen to the 456 objections received against the sale of the land and the decision of this Council's Planning Committee to refuse permission to build on this land. Council therefore concludes that this land should not be sold and that the Executive Cabinet Member, Deputy Leader should reverse his decision.
