Council notes that since 2013, when the scheme was introduced, shoppers and visitors to the town centre had increased hugely. Council therefore requests that a task and finish Policy Development Group be established that would examine the economic consequences on the retail sector, that charging would cause.

Included in this package of measures is to reverse previous plans to end free parking at weekends and to go one step further by extending the free parking at weekend scheme to cover every day of the week for up to two hours. Furthermore to maintain this scheme until the festive period parking scheme comes into force in November.

Council welcomes the deputy leader's decision to reverse the called-in decision and requests that the deputy leader reviews this policy in the new year in the light of the prevailing economic data at the time and brings proposals to a future executive member meeting of the deputy leader early in the new year.
