## **1. TOWN CENTRE PUBLIC SPACES PROTECTION ORDER**

The Director of Place submitted a report which asked the Executive Cabinet Member to consider whether a Public Spaces Protection Order (PSPO) under Section 59 of the Anti-Social Behaviour, Crime and Policing Act , 2014 should be introduced in Bolton Town Centre.

The purpose of the proposed Order was to assist the Council and its partners to provide an appropriate and robust response to anti-social behaviour issues in the Town Centre.

**The Executive Cabinet Member is recommended APPROVED –**

**(i) as a basis for consultation, the development of a Public Spaces Protection Order under Section 59 of the Anti-Social Behaviour, Crime and Policing Act 2014 as detailed in Appendix 2.**

**(ii) as a basis for consultation, Bolton Town Centre as the ‘Prohibition Area’ where the Order will apply (details contained in Appendix 2)**

**(iii) the proposed consultation process, as outlined in section 5 of the report.**

## **2. APPROVAL FOR PROCUREMENT OF WASTE CLEARANCE WORKS AT BURNDEN CLOUGH**

The Director of Place submitted a report which sought agreement from the Executive Cabinet Member to procure waste clearance works at Burnden Clough.

**The Executive Cabinet Member APPROVED –**

- (b) Authorise the Borough Solicitor to carry out all necessary legal formalities.**
