Message from the Independent Chair

I am proud to say that we are starting to improve opportunities and advice for the people of Wigan and Leigh whilst maintaining our level of influence and activity in Bolton.

I am incredibly proud of all the staff, the trustees, the volunteers and the members for taking on the challenges we have faced this year, for being brave and for keeping going when it has sometimes been tough, and I am confident that we have made the right decisions to keep things moving forward. I hope that 2017-2018 will bring a year of plainer sailing, but if it doesn't I think we are well prepared!

Message from the Chief Officer



The backdrop to our year at Healthwatch Bolton has been system change. On 1st April the Government announced, as part of the devolution deal, a fund to accelerate health and social care system transformation and everyone in the Greater Manchester health and care economy began focusing on what needs to be done to revolutionise our services.

As the year went on the Bolton locality plan (the local plan to transform health and care services) began to take shape and the relationships that will be crucial in building a more people centred, more joined up and more sustainable health and care system began to develop and evolve. Healthwatch played a full part in the process of writing the locality plan and continues to be active in the process of monitoring delivery of the plan (as a full member of the System Sustainability and Transformation Board) and is an operational partner (as co-chair, alongside Bolton Community and Voluntary Service (CVS) of the Co-design Enabling Group).

All of this is, of course, quite highfalutin activity and is meaningless unless it is properly embedded into listening to people day in day

out. The wonderful staff at Healthwatch Bolton have of course made sure this happened, keeping up with the changes and keeping going with the day job and doing it all faster! We published an incredible 25 reports - three times as many as last year.

We hit a couple of important milestones as a team this year and I'd like to take a moment to celebrate them. In January we supported our one thousandth client in the Information, Advice and Guidance service. Working away often outside of the limelight this service provides invaluable support to the people of Bolton in helping individuals to resolve their problems, raise their concerns and move forward with their lives. The compassion and expertise of our Information, Advice and Guidance Service staff is unwavering and I am always deeply grateful for their willingness to take on whatever is thrown at them and work with me to try to understand what needs to change to stop these things happening again.

Another important milestone was that we recorded our six-thousandth comment from the public. The engagement team keep this coming, capturing everything that is said in every space and place we visit and ensuring that it is all clearly recorded and handed on so that our research team can use this vital data to develop and present a strong analysis of patient experience.

Listening to people who use health and care services

We collected 2516 comments over the last year and attended over 50 events to carry out engagement and promotion. At these events we have met many people who use health and care services in Bolton.

Enter and View visits

The right to 'Enter and View' is a statutory power of Local Healthwatch. The power allows us to visit health and care providers' premises to see how a service is run and provides an opening to hear the views of service users, carers and staff at the point of service delivery.

Enter and View visits focus on patient experience, they are not inspections but add useful insight into quality of services.

In Bolton we have focussed our Enter and View activity in residential care homes. In 2016-2017 we undertook eight enter and view visits.

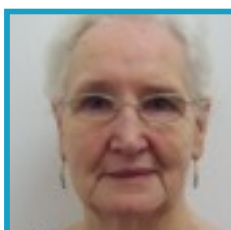

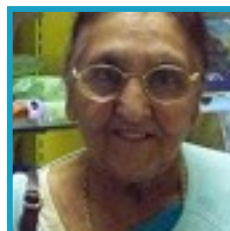

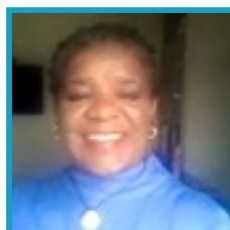

Forums

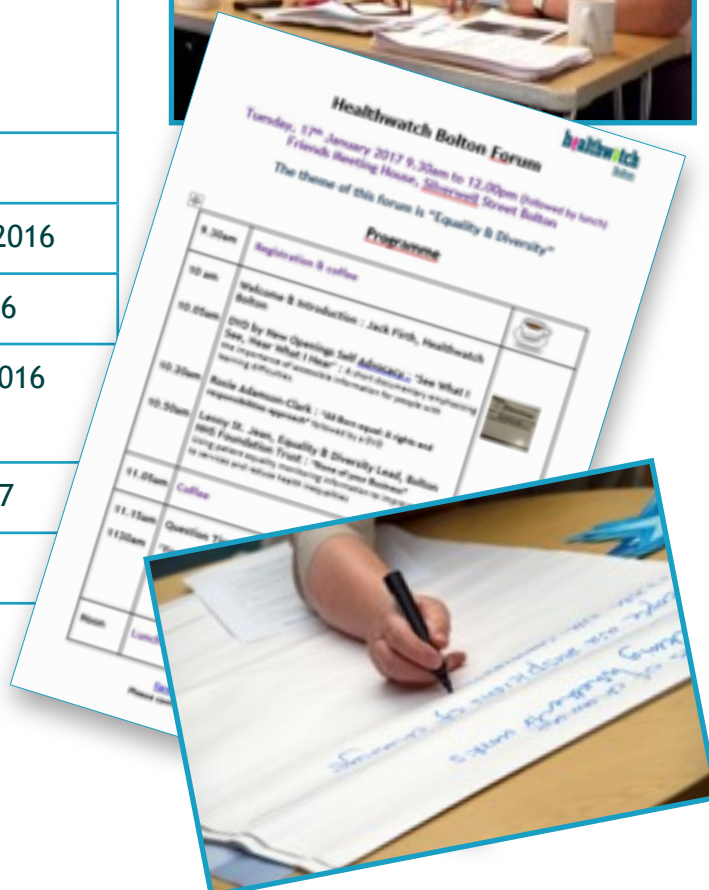
We hold a regular public forum where we invite our members and the public to come along and interact with commissioners and providers of health and care services. We encourage people to get involved in discussions, ask questions of system leaders and participate in the workshops which inform our database. All forums are audio recorded and can be found on our website: healthwatchbolton.co.uk.

We sometimes co-produce forums with other organisations to ensure we include a variety of different service users and carers. This year we held the Health Priorities for Refugees and Asylum Seekers Forum in partnership with Bolton Befriending Refugees and Asylum Seekers (BRASS) and the Care and Carers forum was held in partnership with Bolton Carers Support.

Supporting people with Information, Advice and Guidance

We provide information and advice on health and social care services to the public via telephone and email. During 2016-2017 we dealt with 194 individual advice and guidance cases. We passed an important milestone this year by reaching our 1000th client in January 2016.

We can support people with any question, query or problem they are facing with health and social care services. Our case workers provide a listening ear and clear lines of advice on a whole range of problems. Much of our work is in-depth case work and we are able to support people to navigate the system, to resolve their individual issues, to escalate serious concerns and can advise on how to make a complaint if people wish to do so.

We raise issues with the Clinical Commissioning Group (CCG) Quality Surveillance Group, The Safeguarding Intelligence Forum and with individual services as required.

Healthwatch Bolton continues to coordinate the Advice Providers Group which brings together advice agencies from across the town to discuss shared issues, opportunities and concerns.



We are proud to provide this service to the people of Bolton. Here are some of the things people have said about our Information, Advice and Guidance Service:

Evidence and Reports

By analysing the evidence that we collect from the community, we develop topics for future research. These topics become Thematic Projects. We develop research questions, source engagement opportunities, talk to people, collate the results and produce thematic reports. We are also commissioned to undertake specific pieces of research. This year we have worked with Bolton CVS as part of an engagement alliance on doing some joint engagement around falls and shared care records. We also produce ‘snap-shot’ reports which are produced from small pieces of engagement work to give a flavour of what people think about a service.

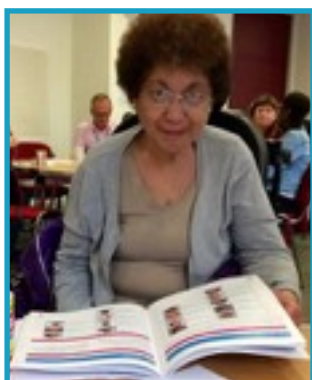

Our Work in Focus

Transforming Health and Social Care in Greater Manchester

Greater Manchester Devolution has brought enormous challenges and opportunities to the people of Greater Manchester and the organisations that serve them including Healthwatch. The scale and pace of change is incredible and getting to grips with what devolution means for health and social care services, for Healthwatch and, most importantly, for people has been a major part of Healthwatch Bolton's work over the last year.



Healthwatch Bolton continues to play a full role in the processes involved in transforming health and social care in Greater Manchester. This involves us being a full partner in the development and implementation of the locality plan in Bolton and being proactive within the Healthwatch in Greater Manchester (GM) Network.

In the spring of 2016 Healthwatch Bolton and Bolton CVS presented a joint proposal to Bolton CCG to develop engagement work around the locality plan themes. The proposal was successful and the Engagement Alliance began work completing engagement projects on falls and electronic care records in 2016. As the year turned the Alliance partners became co-chairs of the Co-design and Engagement Enabling Group and went on to build a strong and vibrant meeting

bringing together strategic and operational leads to build a stronger focus on co-production and engagement, support operational leads and to hold the locality plan task groups to account on their engagement responsibilities.

In March the Engagement Alliance was funded for a further two years from Bolton's Transformation Fund money and we have exciting plans to extend engagement and research activity and increase the opportunities for people to be involved in co-designing services.

On a strategic level, Healthwatch has been a full partner in the development of Bolton's locality plan. We consistently attended the partnership meeting that worked to produce the plan and the bid to the Transformation Fund.

Healthwatch in Greater Manchester (GM)

Throughout the year Healthwatch Bolton continued to play a strong and active role in the Healthwatch in Greater Manchester Network. The network continued to meet monthly to share experiences and information and make plans about joint work.

Jack Firth, Independent Chair of Healthwatch Bolton continued to represent the network at Greater Manchester level and became the network's representative on the Greater Manchester Health and Social Care Partnership Board. Jack also continued to attend the GM Quality Surveillance Group as well as a number of occasional meetings alongside other Healthwatch representatives from Bolton and elsewhere.

Healthwatch Bolton developed- on behalf of the Healthwatch in GM Network - a proposal

for a Healthwatch in GM liaison function. The proposal was presented to the Greater Manchester Health and Social Care Partnership (GMHSCP) in the autumn of 2016 and approved in the spring of 2017. From April 2017 the liaison function will be live with one Healthwatch officer working within the GMHSCP Office to put forward the case for proper public engagement, to ensure Healthwatch is represented in key groupings at GM and to support information flow between local Healthwatch and the GM authorities.

As the formal structures governing the locality plan implementation began to emerge, Healthwatch Bolton was asked to co-chair the Co-design and Engagement Group alongside Bolton CVS and, as a result of this role has a seat on the System Sustainability and Transformation Board. Healthwatch Bolton is also represented on the following task groups; Workforce Enabling Group, Children's and Maternity Strategy Group, Mental Health Strategy Group, Population Health Strategy Group, Urgent and Emergency Care Strategy Group, Primary Care Strategy Group.



Towards a set of Patient Experience Outcomes - Conversations with the people of Farnworth

One of the new delivery models expected by Greater Manchester Health & Social Care Partnership and reflected in the Bolton locality plan is the development of a 'Local Care Organisation' (LCO). Primary Care and some aspects of community based health care activity is expected to be delivered at a neighbourhood level within the framework of the LCO.

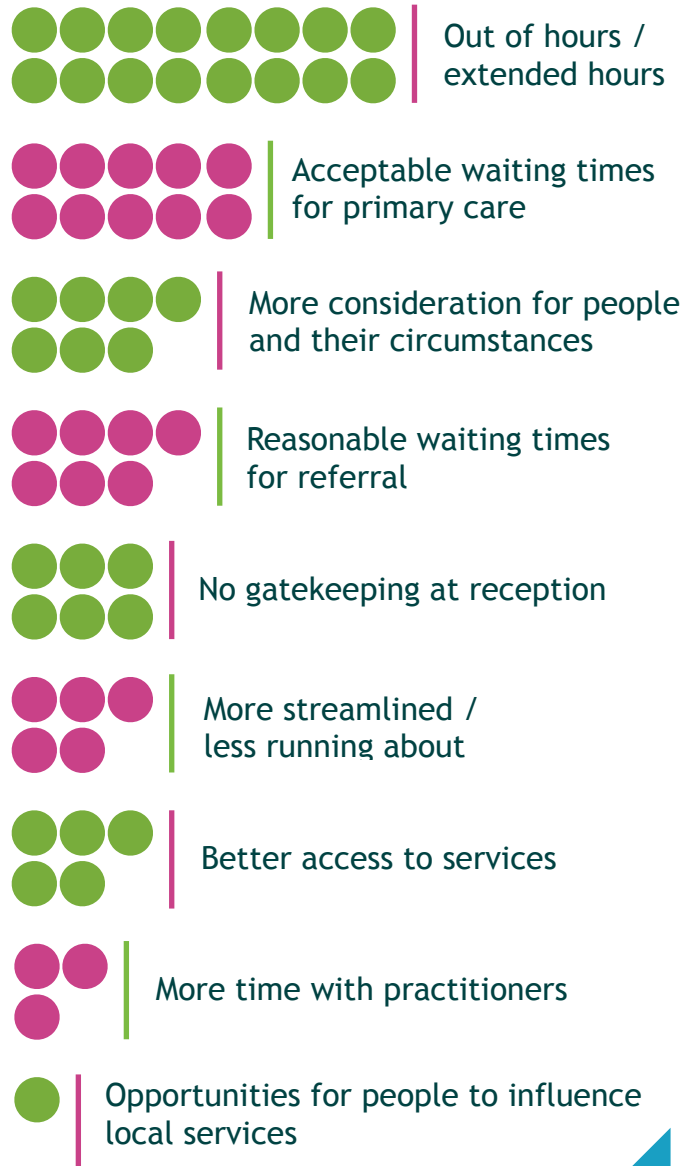
Bolton GP Federation commissioned Healthwatch to find out what patients would want from this new delivery model. We spoke to 59 people at 5 venues in Farnworth, producing 615 comments.

The field researchers explored a number of topics including what services people would want to see in a neighbourhood team and produced a series of five reports under the banner title of Conversations with the People of Farnworth:

Neighbourhood Hubs | Towards a set of Patient Experience Outcomes | What People Think about Waiting Times | Where are People at with Telehealth | Location of Services in Farnworth

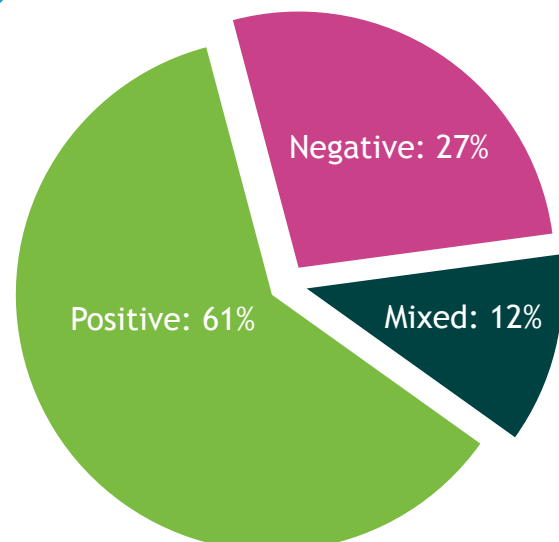
The reports were circulated to a wide range of people within the health and social care economy including all the strategic leads within the Local Transformation Programme, leaders within the Greater Manchester Health and Social Care Partnership, GP leaders, other service providers, voluntary and community groups and individual Healthwatch members.

The reports were extremely well received and have been influential in informing activity, development and plans in terms of Neighbourhood Hubs and, social prescribing, outcomes tool development and Technology Enabled Care (TEC). The graphs [opposite] show some of the information that local people told us.

Change Champions conference - 24th February 2017



In January 2016 Healthwatch Bolton held one of our regular forums on the subject of Greater Manchester Devolution, a straw poll revealed that over three quarters of the people attending (37 people) felt that their knowledge of devolution was very low, were unaware of the scale of the challenge and lacked knowledge about the transformational intention of the Greater Manchester Health and Social Care Partnership.

Most participants were surprised to hear of successful change initiatives in other parts of Manchester such as salaried pharmacists in GPs surgeries, hospital led social care services, GP consortia providing ALL primary care, a new approach to dementia that is being piloted and a new approach to cancer diagnostics which will save repeat referrals.

Following on from this forum Healthwatch Bolton decided to look for some funding to help our volunteers and members explore the idea of change and prepare for their role as Healthwatch members as the Transformation Programme gets underway.

An application was made to the Big Lottery Awards for All programme to fund the work and was successful.

The grant supported a learning and development programme for ten volunteers. The volunteers attended a series of workshops led by Cath Broderick, of We Consult. The workshops explored; what change means; how it affects people and organisations; the benefits of creating change for the greater

good. Individual volunteers looked at various successful change programmes and projects from Bolton and elsewhere.

As the culmination of the project, a large conference was held in conjunction with the University of Bolton, on 24th February 2017. More than 80 people attended, including the Change Champions, Healthwatch members, volunteers and staff, commissioners and managers from Voluntary and Community Sector (VCS) organisations, the public sector and the NHS.

The conference showcased a variety of successful change projects and explored what specific features made the projects succeed. The final output of the conference was a printed report and a Checklist for Change, which is published in the report and available separately on our website.

We intend to develop some work using the Checklist for Change as a tool for monitoring the many change projects that will form Bolton's health and social care locality plan.

Our Volunteers

During 2016-2017 we worked with 78 active volunteers

Volunteers roles include:

Equalities Groups - recruited to monitor hospital changes brought about by Healthier Together to consider equalities issues. The group also work with partners on the Equality Delivery System (EDS) and monitoring.

Community reporters - produce our audio reports from the forums.

Lay readers - review information to ensure that it is legible, user-friendly, understandable and available in different formats.

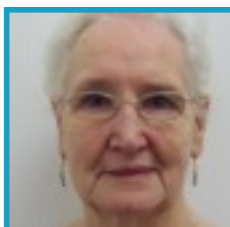
