## 16. WELCOME, INTRODUCTIONS

Councillor Ayub welcomed everyone and introduced Councillor Murray; Councillor Iqbal and other Officers in attendance.

# 17. DECLARATIONS OF INTEREST FROM COUNCILLORS AND OFFICERS

#### 18. MINUTES OF PREVIOUS MEETING

The minutes of the previous meeting held on 29<sup>th</sup> January 2015 were approved as a correct record.

#### 19. PRESENTATION - KEEPING GREAT LEVER CLEAN

Christine O'Reardon, Environmental Services, Enforcement Officer, gave the presentation on Keeping Great Lever Clean as below:

The main Environmental issues affecting the area were:

- Back Street waste/Fly –tipping
- Litter
- Dog fouling

A campaign had been designed to target the problem of back street waste in some of the boroughs most hard to reach areas. The common expectation is that the Council would clear the waste free of charge.

The impact of loose refuse makes communities look untidy and unkempt and creates public health problems by attracting vermin. Additionally, loose refuse provides potential kindling for deliberate fires, an ever increasing problem in Bolton.

## The Impact

The ease of disposing household waste as loose refuse also means that there is low enthusiasm to separate recyclable material from within the waste.

## Recycling:

- conserves resources
- saves energy
- helps protect the environment
- reduces landfill

The Environmental Services have addressed the above issues with residents. Doorstep engagement was effective in increasing awareness and change behaviour towards local environmental issues. A team of community engagement workers visited every property in some of the most challenging areas. A Bin Audit was offered to residents to assist in their understanding of the importance of using the correct bin for the specific type of waste.

The campaign highlighted that legal proceedings are available to the Local Authority and the Police to address the problem of back street waste and fly-tipping, where considered necessary, however, co-operation by changing behaviour in the local communities would be far more agreeable in the long term. Following the engagement process, a series of Zero Tolerance Enforcement Days of Action were implemented to tackle issues of blatant disregard to the Councils efforts to change behaviour.

A resident thanked the Environmental Enforcement team for their recent good work in clearing the back streets of Pennington Road.

A number of questions were raised and answered at the meeting.

Resolved – That the presentation be noted.

Area Co-ordinator and Neighbourhood Manager, John Pye gave a brief update on what had been approved from budgets available to the Area Forum for the 2013 – 2015 financial years.

- A2. PCSO Simon Ratcliffe reported that a man had been sleeping at the back of the William of York school. The Police contacted Urban Outreach who found accommodation for the man. Environmental Services assisted and tidied the area.
- Q3. When the football pitch is full the Children are playing football on the bowling green at Heywood Park and causing damage. Can this be stopped?
- A3. Councillor Ayub would take forward.
- Q4. The hut for the bowling green is broken and it could, eventually, be pulled down altogether by the children. I reported this issue 12 months ago, however, nothing had been done about this.
- A4. Councillor Ayub would take forward.
