15. ADULT LEARNING STRATEGY 2010 – 2013 AND FINAL INSPECTION REPORT – ADULT EDUCATION MAY 2010

A report of the Director of Adult and Community Services was submitted which:

- (a) put forward the Adult Learning Strategy 2010/13 for consideration and approval; and
- (b) outlined the findings of the Ofsted inspection into the Council's Adult Safeguarding Learning provision which had taken place in May, 2010, together with details of the Page 1 of 3

Inspector's recommendations.

With regard to (a) above, the report informed the Executive Member that the Adult Learning Strategy had been prepared following an extensive consultation exercise with a variety of interested parties and aimed to ensure that coherent, inclusive and high quality learning was available for all adults in Bolton. The Strategy would assist in improving functional skills such as basic literacy, language and numeracy skills and ensure all adults established a basic platform for employment.

A full copy of the Strategy was attached at Appendix 1 to the report.

With regard to the Ofsted Inspection Report, the report informed the Executive Member that the Council's Adult Safeguarded Learning Provision was inspected by a team of HMI Ofsted Inspectors between 10th and 14th May, 2010 at Bolton Community College, the sole provider for the Council's Skills Funding Agency ASL Contract. The report described the findings and comments as very positive. The Adult Learning was rated as good and was awarded a Grade 2 with capacity to improve to outstanding provision. The weaknesses lay with the sub contracted provider processes and were being addressed under the development of the Quality Improvement Plan.
