# 1. MONITORING OF EXECUTIVE MEMBER DECISIONS

The Borough Solicitor submitted a report which set out details of the decisions made at previous meetings and the progress on each to date.

The Executive Cabinet Member NOTED the report.

### 2. PETITION REQUESTING WAITING RESTRICTIONS OUTSIDE THE BUSINESSES NO 534 -556 CHORLEY OLD ROAD

The Director of Environmental Services submitted a report which set out details of a petition which had been received from businesses in No 534 – 556 Chorley Old Road for limited waiting parking restrictions to assist their customers.

The report set out further details of the petition request and various comments from officers.

Following a recommendation from the Cabinet Member for Highways, Transport and Community Services the Executive Cabinet Member APPROVED –

The introduction of limited waiting parking restrictions in the areas supported in principle subject to preconsultation with local businesses and funding being made available.

# 3. PETITION REQUESTING WAITING RESTRICTIONS AND TRAFFIC CALMING ON COLLIERS ROW ROAD AND WALKER FOLD ROAD

The Director of Environmental Services submitted a report which set out details of a petition which had been received from residents, walkers, horse riders and cyclists requesting the introduction of a weight restriction and traffic calming measures on Colliers Row Road and Walker Fold Road to improve road safety on this route.

The report set out further details of the petition request and various comments from officers.

Following a recommendation from the Cabinet Member for Highways, Transport and Community Services the Executive Cabinet Member APPROVED –

The introduction of a weight restriction on Colliers Row Road and Walker Fold Road is not supported. The introduction of traffic calming on Colliers Row Road and Walker Fold Road is not supported, however, more suitable traffic management measures with a reduction in speed limit are supported subject to funding being made available.

4. WASHINGTON STREET / HOVE STREET NORTH / FERN STREET – PROPOSED WAITING RESTRICTIONS / LOADING BAY ORDER – OBJECTION

The Director of Environmental Services submitted a report which set out details of objections which had been received to the proposed introduction of waiting restrictions and a loading bay order on Washington Street / Hove Street North / Fern Street, Bolton.

The report explained that the Director of Environmental Services had previously agreed the promotion/revocation of waiting restrictions and the introduction of a loading bay order on Washington Street, Hove Street North and Fern Street in order to facilitate development.

The proposal was advertised in March/April 2015 and 5 written representations were received along with a petition containing 21 signatures. The report set out the reasons given for the representation and gave a response to them. In conclusion, the report explained that the cost of the proposals for the traffic orders would be funded by the developer.

Following a recommendation from the Cabinet Member for Highways, Transport and Community Services the Executive Cabinet Member APPROVED –

having considered the objections received and the views of ward members the introduction of the proposed no waiting at any time restriction / loading bay order with the amendments indicated in the report to the ones advertised in March/April 2015.

# 5. ENVIRONMENTAL SERVICES FINANCE REPORT – FINAL OUTTURN
