Equality Impact Assessment Questions

1. Describe in summary the aims, objectives and purpose of the proposal, including desired outcomes:

Purpose:

The Council is responsible for issuing licences for the provision of both private hire and hackney carriage. A licence is issued subject to a person meeting certain criteria covered in both legislation and Council standards.

A licence is issued pursuant to the provisions of Part II of the Local Government (Miscellaneous Provisions) Act 1976 and the Town Police Clauses Act 1847. The law prohibits the Council granting a licence to a person unless they are satisfied that the person is 'a fit and proper person'

The Council is also responsible for granting contracts for the provision of social needs transport. A contact is granted subject to Council standards, the tender framework and the terms and conditions.

The proposals contained in the 'Statement of Fitness & Suitability' (Private Hire, Hackney Carriage & Social Needs Transport)' outline these standards and the Councils ongoing responsibilities.

The proposed statement is modelled on the framework developed by the Association of Greater Manchester Authorities (AGMA), with the objective of ensuring transparency and consistency across region. There may be variations in the content of the statement across the region due to each Councils own policies requirements.

Objective

The Council is committed to ensuring that:

- All persons that hold a licence or provide social needs transport are 'fit and proper persons' or in simpler terms they are both 'safe and suitable'
- The public are not exposed to persons with a history of dishonesty, indecency or violence or any other offence or inappropriate behaviour which may question the persons 'fit and proper status
- The safety of children, young persons and vulnerable adults is protected

Aim:

The proposals contained in the 'Statement of Fitness and Suitability' enables the Council to ensure a robust licensing and social needs transport regime, that protects safety and commands the confidence of members of the public. The Council will always put the protection of the public first when considering any information recorded against a person applying for a licence, renewing a licence, or where a licence is being reviewed and when granting or reviewing a contract to provided social needs transport.

By including convictions, other formal action, intelligence and non-convictions within the proposals the Council is ensuring that any person applying for a licence, renewing a licence, or a person whose licence is being reviewed or a person providing social needs

transport, meets the Councils standards and is a 'fit and proper person' and that that the Council standards are not solely based on convictions, but also take into account a person's conduct and behaviour.

Consultation will be undertaken with statutory consultees and the wider community.

2. Who are the main stakeholders in relation to the proposal?

The proposals will be considered by the following consultees as part of the consultation exercise:

- Trade representative for both private hire and hackney carriage
- Private hire operators
- Greater Manchester Police
- Officers of the Council
- Members of the Licensing & Environmental Regulation Committee
- Members of the Licensing & Environmental Regulation Subcommittees

Elected Members will be consulted through the appropriate internal processes.

3. In summary, what are the anticipated (positive or negative) impacts of the proposal?

It is not anticipated that the proposals will have a significant impact. The proposals are updating the existing Council 'Statement of Policy and Guidelines Relating to the Relevance of Convictions'. There is already a strong degree of consistency in the current Council licensing and social needs transport regime and the proposals are building on the current framework.

The proposals provide clarity and guidance for private hire, hackney carriage and social needs transport providers, for any person with a conviction, who has had other formal action taken, or where there is intelligence or other non-convictions matters. It sets out the Councils standards and decision making process. The proposals provide guidance for decision makers by outlining a range of minimum periods to be applied to convictions, other formal action, intelligence and non-convictions. The proposals support the wider context of the Councils duty under the safeguarding agenda, in particular child sexual exploitation.

Impact for the business community

For the business community, the proposals provides guidance and a framework for anyone with an interest in private hire, hackney carriage or the provision of social needs transport. The proposals set out <u>minimum</u> standards to be applied to a range of convictions, other formal action, intelligence or non-convictions, etc. and it explains in very general terms a 'fit and proper' test. However it is important to remember that each case will still be determined on its individual merits.

The proposals now include the providers of social needs transport and will help the Council ensure a robust licensing and social transport regime, that protects safety and command the confidence of members of the public.

The principles governing the proposals remain consistent with the previous policy and it recognises the wider community impacts that the Council, business community and other

stakeholders must be aware of when operating in this area.

There is recognition in the proposals of the need to balance the rights of businesses and the community and also recognises the aim of the Council is public safety.

Impact for the wider community

The proposals will ensure a robust licensing and social needs transport regime; that protects safety and commands the confidence of the general public. The Council will always put the protection of the public first when considering any information recorded against a person applying for a licence, renewing a licence or having a licence reviewed or when awarding or reviewing a contract to provide social needs transport.

The consultation period ran from Wednesday 17 February 2016 to Wednesday 16 March 2016.

A letter was sent to a range of stakeholders including taxi operators, taxi trade representatives, police, magistrates court and elected members (as representatives of residents). A full list of consultees is given below.

The letter asked stakeholders to review the proposed Statement on the website (paper copy available on request) and provide comments. In providing comments, stakeholders were asked to inform the council how the updated policy would impact on them or the organisation they represent, any impacts on particular vulnerable groups, any proposed

mitigation measures to off-set these impacts and any further proposed changes to the statement.

Stakeholders were asked to submit comments by email or in writing (a pre-paid envelope was provided). A face-to-face meeting or telephone discussion was offered to anyone who preferred this.

- b. Please summarise the results of this consultation, including key issues arising and any changes being made to the proposal as a result of the consultation.

Three comments on the statement have been received. The comments related to licensing processes and how these can be clarified or improved and these suggestions can be incorporated into practices.

There is a general outline of the comments below and this includes a brief summary response (the full consultee responses is available if required):

i. Elected Member comment - request for reassurance that applicants / license holders are given the opportunity to put their case forward prior to decisions relating to non convictions.

Response - The Licensing Unit can clarify that all such issues are considered as part of a hearing as outlined at paragraph 3 of the Statement of Fitness & Suitability.

ii. Private hire operator comment - CRB check you should carry out the health and safety check at the same time as doing it yearly will be costly for all drivers.

Response – The Licensing Unit can confirm that the 'fit and proper' test is applied to all driver and operator applications and renewals and currently a DBS(CRB) is completed every 3 years. The 'fit and proper' test is a continual test applied by the Council as long as the licence remains valid as outlined in paragraph 2 of the Statement of Fitness & Suitability.

 iii. Service provider officer comment – Where licences are not approved or revoked/suspended this information needs to be formally notified to Social Needs Transport (SNT). Persons that do not hold a private hire/hackney carriage licence issued by Bolton Council expert advice and guidance could be provided by a the Licensing Team or the Committee.

Response – The Licensing Unit can confirm that information is currently shared, but a more robust notification process is currently being developed. Further consideration of involving the Licensing Unit and Committee with SNT will be explored.
