1. FINANCIAL MONITORING OUTTURN REPORT 2017/18

The Interim Director of People submitted a report which provided information relating to the financial position for Children's Services for the 2017/18 Financial Year.

3. ESTABLISHMENT OF TWO FINANCIAL ADMINSTRATOR POSTS

The Interim Director of People submitted a report which sought approval to establish two posts of Financial Administrator (Grade 3) to deliver capacity across the Children's, Adults and Public Health Commissioning and Financial Income Assessment Areas.

4. ESTABLISHMENT OF COMMISSIONING OFFICER POST

5. SPECIAL EDUCATIONAL NEEDS TRANSPORT - POLICY REVIEW
