					Of the locally raised funds for all the Masterplans in this borough, Bolton received £88 million whilst four remaining towns in the borough received just £3 million each with a possible further £4 million to be shared between these smaller towns depending on the sale proceeds of land in this borough.
					It is my belief, and also that of many residents that the commitment of Council funds to Farnworth is both inadequate and unfair. Disregarding land sales – also known as SAMP - Bolton is receiving £88 million yet Farnworth is receiving only £3 million. It should be noted that this Council's funding for the library/health centre in Little Lever

is more than the none-land-sale commitment to the entire town of Farnworth. Along with other Councils that bid for the first tranche Future High Street Funds [FHSF], Farnworth received only 69% of its original bid resulting in a nearly £6 million shortfall. Of the proposed combined £23 million taxpayer funding, Farnworth received only £17 million, and the Farnworth Masterplan had to be scaled-down to reflect the – reduced - secured funding from central government. The main throughfare through Farnworth is Market Street and between the Longcauseway and Rawson Street junctions of Market Street – a distance that is actually longer than Deansgate in Manchester – there are rows of shops and the vast majority of these shops are shuttered. The same stretch of road is also the main section of the 'Streets for All' scheme. In other parts of the UK, many shutter-blighted High Streets have been transformed using innovative adaptations to shop frontages including the main windows and doors being slightly set back and at an angle so that more attractive methods of security can be used. The scaled-down version of the proposed Farnworth Masterplan included the removal of funding for shop-frontages on
Market Street and this is hugely disappointing given the opportunity to truly transform the town, and in the very least make up for the decades of neglect of the second town of the borough.
We were previously told that this Council is capital rich. When it comes to Bolton Town Centre, there appears to be a determination – no matter what it costs – to ensure that the Masterplan there is successful. In contrast, Farnworth has to make do with whatever scraps of finance this Council

					wants to give.
