1. Introduction

Members will be aware that part of the remit of this Scrutiny Committee is to monitor and review and where appropriate make recommendations, regarding the work of outside organisations. This report focuses on one aspect of this, in terms of the added value provided by the AGMA bodies of the AGMA Executive, The Combined Authority, Greater Manchester Fire and Rescue Authority, Greater Manchester Police Authority, Greater Manchester Waste Disposal Authority and Transport for Greater Manchester. Those amendments have subsequently been made and a revised version of the strategy is attached to the report.

Strategic Growth and Reform Plan

A report proposing to develop a Greater Manchester place-based Growth and Reform Plan that complies with the guidance but that delivers against the breadth of our objectives and emphasises the interconnectivity of the growth and reform agendas.

Rail North: Long Term Rail Strategy

Low Carbon Hub Procurement
