70. MOTION UNDER STANDING ORDER NO. 4 – FLYING OF THE UNION JACK FLAG IN SCHOOL GROUNDS/NATIONAL ATHEM AT ASSEMBLIES

That this Council, via the office of the Director of Children Services, would like to encourage our schools (primary and secondary) to fly the Union Jack flag in our school grounds throughout the Borough and encourage them to include the National Anthem as part of school assemblies.

71. MOTION UNDER STANDING ORDER NO. 4 – INCREASED SEATS ON BOLTON COMMUTER TRAINS

It was moved by Councillor J. Walsh and seconded by Councillor Wild -

That this Council welcomes the pledge by the Prime Minister that, "..Having listened to the people of Bolton we're making sure that before the end of the year we will lengthen trains ... which means 200 extra seats on those key morning commuter trains".

Upon being put to the vote, the motion was declared carried.

72. MOTION UNDER STANDING ORDER NO. 4 – FIXED ODDS BETTING TERMINALS

It was moved by Councillor Lewis and seconded by Councillor Jones -

This Council notes:-

- The prevalence of Fixed Odds Betting Terminals (FOBTs) in many betting shops across Bolton, dubbed in the media as the "crack cocaine of gambling".
- That, unlike fruit machines in pubs, bingo halls and amusement arcades (where cash stakes are limited to £2), gamblers can bet up to £100 every 20 seconds on FOBTs to win a jackpot of £500. This is more than 4 times faster than the rate of play in casinos.
- That nationally 80% of betting shop turnover is generated by FOBTs, with only 20% coming from more traditional over-the-counter betting on sports and racing. In Bolton there are currently 50 betting shops with 182 FOBTs, in which a gross amount of £196m was gambled in 2012:-

Bolton North East – 14 betting shops – 51 FOBTs – £55m gross amount gambled; Bolton South East – 25 betting shops – 91 FOBTs – £98m gross amount gambled; and Bolton West – 11 betting shops – 40 FOBTs - £43m gross amount gambled.

- The recent economic analysis undertaken by Landman Economics, commissioned by the Campaign for Fairer Gambling, to assess the impact of the growth in FOBT spending on local economies and across the wider consumer economy. This report highlights that an extra £1b FOTB spend produces a net reduction of 13,000 jobs and that the projected doubling of FOBT revenue by 2023 could destroy 23,000 jobs. The report also highlights the negative impacts of the increase in new betting shops and the relocation of existing shops to primary retail sites.
- The lack of action by central government to address the issues caused by FOBTs, and the announcement made last October by the Secretary of State for Culture, Media and Sport, Maria Miller MP, not to regulate maximum stakes, speed of play and maximum jackpots. Council notes in contrast the position in the Republic of Ireland where the Government has introduced legislation to outlaw FOBTs in betting shops.

Council believes that the proliferation of FOBTs is causing significant problems in Bolton and believes that the Government should introduce legislation to ban FOBTs in betting shops or, at the very least, give local authorities the powers to protect the wellbeing of communities.

Council therefore agrees to:-

 write to the Secretary of State for Culture, Media and Sport to outline the terms of this motion and demand urgent action against FOBTs by the Government;

- support the proposal under the Sustainable Communities Act by Hackney Borough Council that the Government creates a separate planning class use for betting shops; and
- explore other steps that could be taken within existing powers in Bolton to reduce the problems caused by FOBTs in our town in the absence of further Government action.

Upon being put to the vote, the motion was declared carried.
