ANNEXES

Annex 1 - Mandatory conditions where licence authorises supply of alcohol

- 1. No supply of alcohol may be made under the premises licence
 - a. At a time when there is no designated premises supervisor in respect of the premises licence, or
 - b. At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

The following conditions shall come into force on 6th April 2010

- 1. (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children-
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);

- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
- (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-
 - (i) the outcome of a race, competition or other event or process, or
 - (ii) the likelihood of anything occurring or not occurring;
- (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti- social behaviour or to refer to the effects of drunkenness in any favourable manner.
- 2. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 3. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

The following conditions shall come into force on 1st October 2010

- 4. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 5. The responsible person shall ensure that-
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml; and
 - (b) customers are made aware of the availability of these measures.

The following conditions shall come into force on 28th May 2014

Ban on sales of alcohol below the permitted price

The relevant person (the holder of the premises licence, the designated premises supervisor (if any) in respect of such a licence, the personal licence holder who makes or authorises a supply of alcohol under such a licence, or any member or officer of a club present on the premises in a capacity which enables the member or officer to prevent the supply in question) shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

The permitted price is defined as the aggregate of the duty chargeable in relation to the alcohol on the date of its sale or supply and the amount of that duty multiplied by a percentage which represents the rate of VAT chargeable in relation to the alcohol on the date of its sale or supply. Detailed guidance on how to make this calculation and a calculator to determine permitted prices for each product are available on the Home Office website.

Where there is a change to the rate of duty or VAT applying to alcohol (for instance, following a Budget), the relevant person should ensure that the permitted price reflects the new rates within fourteen days of the introduction of the new rate.

It is still permitted to sell alcohol using promotions (as long as they are compatible with any other licensing condition that may be in force), and the relevant person should ensure that the price of the alcohol is not less than the permitted price. Detailed guidance on the use of promotions is given in the guidance document available on the Home Office website

Annex 2 - Conditions consistent with the operating schedule

General

Premises are monitored by 24 hour CCTV and recordings will be kept for 30 days. Challenge 25 is in operation and SIA badged door staff will be on the door from 9pm on weekends and busy evenings such as bank holidays and seasonal events. Pubwatch meetings will be regularly attended and we will be part of the town radio scheme.

The Prevention of Crime and Disorder

Staff training with regards to relevant issues.

Challenge 25 in operation.

We will not serve people who have had too much alcohol.

The premises will operate an effective CCTV system that will be maintained in full working order at all times the premises are open for business. All CCTV images will be maintained for a minimum of 30 days and will be made available to responsible authorities on request. The system will be to the satisfaction of the GMP licensing officer. The premises will employ SIA registered door staff each Friday Saturday and Sunday's of a bank holiday weekend from 9pm until the premises are closed for business.

The premises will employ SIA door supervisors between 9pm and close of business on all other key dates such as mad Friday, Christmas Eve, Boxing day and New Year's eve.

The premises will only employ Door staff registered by the Approved Contractor Scheme (ACS) or to the satisfaction of the GMP Licensing officer.

All incidents and refusals will be recorded. The incident and refusals register will be maintained on site and all incidents and refusals will be recorded in the said document as soon as possible, but in any case prior to the close of business on the date of the incident.

The incident/refusal register will be made available to responsible authorities on request.

The premises will play softer and slower music for the last 30 minutes of operation in order to encourage customers to drink up and disperse from the premises in an orderly and controlled manner.

The premises will be a full an active member of the local pub watch scheme. The monthly pub watch meeting will be attended by the DPS. The premises will employ a clicker system to ensure capacity levels are not breached.

The premises will effectively utilise a town centre radio link. The system will be used effectively to monitor and share information in relation to incidents and would be trouble makers within the vicinity.

Public safety

Regular risk assessments completed as well as investment in staff training and development.

Health and safety policies and procedures in place – PAT testing etc. Water available for customers at all times. Drinks not permitted outside the venue.

We will attend regular pubwatch meetings.

SIA badged staff will be on the door from 9pm on weekends and busy evenings such as bank holidays and seasonal events.

Training of staff to be observant of troublesome customers.

We will click people in and out to ensure we don't exceed maximum capacity.

Part of town radio scheme.

Challenge 25 in operation.

We will not serve people who have had too much alcohol.

To ensure that customers drink in a safe environment.

Water available for customers at all times.

Drinks not permitted outside the venue.

No persons under 18 years of age will be permitted on any part of the premises after 8pm.

Children under the age of 18 will only be permitted on the premises until 8pm if they are accompanied by a responsible adult at a pre- arranged private event.
