1. INTRODUCTION AND WELCOME

Councillor Adia welcomed everyone and introduced Councillor Ibrahim and other Council and partner officers present.

5. DEANE UCAN ACTIVITY UPDATE - PRESENTATION

Mary Devenish, Bolton at Home gave the following presentation on the Deane UCAN Anti-poverty project and Community Cohesion activities from April 2016 – August 2016. The project aimed to:

- More focussed interventions to get people into work, training or volunteering
- Improved access for Community English Classes and other integration projects
- Other anti-poverty provision

Employment Provision:

- Work Club New registrations 120 residents (April to July)
- Barrier Busting intense one to one support to remove barriers to work
- CV service assist residents to develop a good CV
- BEST Programme
- I.T training to help residents set up e-mail accounts, enable them to fulfil Universal Credit requirements

Outcomes April – July

- Into paid employment 47 residents
- Accredited Courses 5
- Unaccredited courses 47
- Into further education 2
- Careers advice 59

Integration:

- An extended Community Café is commencing in October (on Tuesdays from 11.00 a.m.) at the Willows Centre. Volunteers will cook food from one of their own recipes. The recipes will be given out for everyone to try out. Everyone welcome.
- During the summer holidays Community Volunteers at the Willows centre provided packed lunches for 60 children throughout the week. The children also took part in Arts and Crafts.

Progression route for ESOL

- Community English Class at Willows
- Working with Workers Education Association (WEA) lets get ready for ESOL
- Onto accredited ESOL via WEA
- More Co-ordination in Rumworth on English Classes

Other Anti-Poverty Provision:

- Money Advice Team for Bolton At Home Customers
- Money Skills and Salvation Army for other residents needing Debt advice
- Energy efficiency training savings for customers through changing suppliers, cheaper tariffs, dual fuel and direct debit
- Keep Warm for Less –grant applications just commencing partnering with Money Skills and Salvation Army
- Food Vouchers provided to residents who have no food in the house many with children
- Local Welfare Provision average 12 per month

6. UPDATE ON BUDGETS DEVOLVED TO THE AREA FORUM

Vivienne Morris, Neighbourhood Renewal Manager gave a brief update regarding the devolved budgets to the Area Forum available for April 2015- March17:

Budgets for 2015/17 devolved to the Area Forum are as follows:

Area Forum Flat Rate £9,375 Balance £9,375

Highways Maintenance Budget annual allocation - £19,200

Ward Councillors had agreed the following schemes for repairing the road surface:

Oriel Street/Cambria Street estimated cost is £37,300.

Part Deane Church Lane to Wigan Road estimated cost is £33,000.

All estimates are above the budget awarded, Highways have agreed to contribute the shortfall.

Balance = £0

Resolved – That the update, together with those projects approved under the council's Scheme of Delegation be noted.

7. QUESTIONS AND ANSWER SESSION

Councillor Adia introduced this agenda item and invited all Forum attendees to ask any questions they may have regarding issues in the Rumworth Ward.

One written question from Alan Johnson had been submitted on the night.

- Q1. I would like to ask the councillors what is their view on the proposed closure of 12 Childrens Centres and what impact would the closure of Harvey/Alexandra Centres have on vulnerable families in the ward. Why could Council reserves not be used to cover or meet the £1.5 million.
- A1. Cllr Adia responded that as a consultation was currently ongoing he couldn't comment but advised that any comments/ideas should be put forward into the consultation process. A final decision on the proposals could not be made until after the end of the consultation and comments/ideas had

been looked at. He also explained that this was in a context of reducing budgets and the fact that over the past five years the council had to save £100 million and that another £40+ million was still to be found.

The Council has Statutory responsibilities that is has to fulfil, and whilst having a legally balanced budget. Decisions about reducing services especially when it affects children are always a difficult balance and are not taken lightly.

A lot of the Council's reserves are already allocated. Reserves can only be used once, so money would have to be found again to fill any shortfall in a service.

Q2. A resident stated that she was disappointed at the method that Bolton Council is using to consult the residents on the issue of the closure of the Children's Centres. The actual consultation document is not good. Some people in areas of the borough may not be able to understand and respond to the questions. Face-to-face consultation with the residents would have been better. More background work should have been done before the document was sent out for consultation. We need the correct information on people's opinions regarding the closure of the Centres.

A Parliamentary group study document reported that all Parent groups and Children's Centres and Community Hubs are the way forward, however, we are now stigmatising these groups.

A2. Councillor Adia informed the resident that they should feed their comments into the consultation.

Resolved – That the questions and answers be noted and those that were not answered be directed to the appropriate departments or partner agencies.
