41. MINUTES

The minutes of the meeting of the Schools Forum held on 17th September, 2021 were submitted.

42. DSG FINANCIAL MONITORING REPORT, QUARTER TWO, 2021/22

The Director of Children's Services and the Deputy Chief Executive submitted a report which provided information in relation to the financial position for the Dedicated Schools Grant for the 2021/22 financial year as at quarter two.

Resolved – That the expected financial position as at 31st March, 2022 and the changes in the capital programme be noted.

43. SCHOOL FUNDING CONSULTATION 2022-23

The Director of Children's Services submitted a report which updated the Forum on the latest budget announcements, the spending review and discussed the principles to be adopted in the school budget consultation for 2022-23.

The report referred to increases built into the funding formula, key features of a local authority funding formula and the initial DSG settlement.

In terms of the spending review, HM Government had now published its review for the period 2024-2025 and this detailed an increase to the core budget of £4.7bn by 2024/25 compared to the original announcement.

The report also updated in terms of unit values, the high needs block, the consultation, de-delegation and school improvement de-delegation.

In conclusion it was reported that the consultation outcome would be reported to the next meeting of this Forum.

Members in their discussions referred to –

- The position regarding the high needs block;
- Any plans to reduce the 2% mfg over time;
- Briefing schools; and
- The rates re early years.
