

The response of the Executive Member to Cllr Peel was "we don't want the end of sub committees either but we have been told we have no choice with political balance." 					The Council has never needed to obtain the permission of Bolton at Home to publish its own figures, yet in 2019, despite having the information itself, the Council requested information on the Breightmet NM spend from Bolton at Home, which Bolton at Home kindly (but unnecessarily) supplied. This information was never published by the Council.
